Golf

33.1 Golf Format

33.1.1 The CAA staff will organize High school and Junior High competitions

33.1.2 These competitions will include:

33.2.1 Regular Season Individual Competitions

33.2.2 Regular Season Team Competitions

33.2.3 State Championship Tournaments in Singles and Team

33.1.3 Regular season competitions will consist of the following:

33.1.3.1 Dual events

33.1.3.2 Multiple School Events

33.1.3.3 High school and Junior high events on Saturdays organized by CAA staff

33.1.3.4 Events can be 9-hole or 18-hole as determined by the host school

33.2 Golf Team Structure

33.2.1. Schools may have as many competitors as it want in an individual competition or as limited by the host school

33.2.2 Team scoring:

33.2.2.1 Junior high team score will be the cumulative score of the 4 team members

33.2.2.2 High school team score will be the cumulative score of the 4 team members

33.2.2.3 If a team does no not have the required number of players to enter a team score then it cannot compete in a team competition

33.3 Golf Scoring

33.3.1 Player match results will be recorded weekly

33.3.2 HS results will be posted on the CAA website weekly

33.3.3 JH results will be sent to the coaches and AD's for them to distribute to their team

members (Federal Law)

33.4 Event Registration Guidelines

33.4.1 All schools will register their players for a regular season event with the event coordinator 4 days before the event

33.4.2 Upon arrival at any golf event the coach and each player should register at the event scoring table

33.5 GAME TIME AND LATE ARRIVAL

33.5.1. The following CAA rules shall govern when a team or player arrives at the meet late:

33.5.1.1 Match Time is Forfeit time which means a player will not be allowed to compete.

33.5.2. Schools should call the hosting event coordinator if for some reason they will be late or not able to attend the competition at any given event.

33.6 COACHING - Refer to Article 4

33.7 Participation fees

33.7.1 Team season fee: Determined each year by the CAA Executive Board and posted on CAA website

33.7.2 Player event fee: Determined each year by the CAA Executive Board and posted on CAA website

33.8 Regular Season Hosting

33.8.1 Any Golf event that is hosted by a member school should be certified by the CAA Golf Director so the event can be put on the CAA Golf calendar

33.8.2 Any Golf event hosted by the CAA will have an event coordinator and scoring coordinator

33.8.2 Any Golf event should have a event coordinator at the event

33.8.3 Any Golf event should have a Registration and scoring coordinator at a designated table

33.9 Etiquette rules during play:

33.9.1 Any situation that needs an outside decision will be decided by an agreement of the coaches of the teams involved in the match. If they cannot reach an agreement then they will ask the remaining coaches in attendance to come to a decision. If it is a CAA staffed event, the official CAA event coordinator will make a final decision when necessary

33.9.2 When players finish a golf match, the players have a final outcome decided ...all players will go to the scoring supervisor table and report the match result.

33.9.3 Players will clean up the scoring area before leaving the facility

33.10 Sportsmanship and Ejections - Review Article 12

33.11 State Golf Championships

33.11.1. To be eligible for the Team and Individual Championships a player must register a minimum of 3 match results during regular season competitions.

33.11.2. At the Team and Individual CAA Championships, the CAA Golf Director will act as the scoring supervisor with an assistant and also will be the final decision on any issues that need a ruling.

33.11.3 All schools will register their players for a CAA State Championship event with the CAA event coordinator 4 days prior to the event

33.11.4 Tee times and composition of foursomes will be assigned by the CAA Golf Director

33.11.5 The CAA Junior High Championships will be a 9-hole event

33.11.6 The CAA High School Championships will have 2 events:

33.11.6.1 CAA will host a 9-hole championship for inexperienced players

33.11.6.2 CAA will host a 18-hole championship for more experienced players

33.12 CAA State Golf Team Tournament Trophies

33.12.1 CAA State Championship 9-hole JH Team trophies: 1st, 2nd

33.12.2 CAA State Championship 18-hole HS Team trophies: 1st, 2nd

33.13 CAA State Golf Championship JH Singles Trophies:

33.13.1 9-Hole Championship: 1st, 2nd, 3rd , 4th and 5th

33.14 CAA State Golf Championship HS Singles Trophies:

33.14.1 9-Hole Championship: 1st, 2nd, 3rd , 4th and 5th

33.14.2 18-Hole Championship: 1st, 2nd, 3rd , 4th and 5th
