# ARTICLE 25 Track and Field

#### 25.1 GENERAL INFORMATION

- **25.1.1** The CAA shall adopt the current edition of the National Federation of State High School Association (NFHS) Track & Field Rules and Regulations. These rules shall govern unless noted below.
- **25.1.2** Any discrepancies will be ruled upon by the league director and/or Competition Committee.
- **25.1.3** The CAA delegates all responsibilities for Track & Field meets to the individual schools participating in these meets. The regulations listed here are intended to create a fair and consistent set of guidelines for these meets. The Meet Director is responsible for all questions regarding their individually held meet.
- **25.1.4** CAA officials will be assigned to all CAA Certified Meets and paid directly by the CAA.

# 25.2 COACHING - Refer to Article 4

### 25.3 REGULAR SEASON MEETS

- **25.3.1** CAA will be responsible for organizing Regular Season meets.
- 25.3.2 Entry Fee: CAA Executive Board will determine the fee structure on an annual basis.
  - **25.3.2.1** Schools will be invoiced by the CAA according to the number of registered athletes.
- **25.3.3** CAA will provide team awards at each meet.
- **25.3.4** Meet results will be posted on the CAA website.
- **25.3.5** Meet registration must be completed in Athletic.net by Wednesday, 8:00 PM prior to Saturday meets, unless otherwise noted.
  - **25.3.5.1** Deadline is 8:00 PM the Monday prior for all Wednesday meets.
- **25.3.6** Coaches/Parents are not allowed on the In-Field once the meet has started. Loss of 10 team points for each unauthorized infraction without warning.
- **25.3.7** Girls will start first on Odd Years. Boys will start first on Even Years.

## 25.4 EQUIPMENT, FIELD AND UNIFORM GUIDELINES

- **25.4.1** Uniform Refer to NFHS Guidelines.
- **25.4.2** Participating schools will provide all field implements for their athlete use. Implements must be weighed and approved by the CAA Field Official during the scheduled weigh-in time. All implements not meeting minimum specs during weigh-in will be required to stay with CAA until the completion of the event. Each school is responsible for their own implement(s).
- **25.4.3** Schools must provide their own Starting Blocks.

### 25.5 GAME TIME AND LATE ARRIVAL

**25.5.1.** Meet Time is Forfeit time. All Events run on a rolling meet schedule.

#### 25.7 STATE CHAMPIONSHIP INFORMATION

- **25.7.1** The CAA will host a Track & Field State Championship meet at the end of the season.
  - **25.7.1.1** The CAA will collect all entry fees and pay for all costs to run the state meet.
  - **25.7.1.2** A CAA representative will be present to officiate and award trophies.
- **25.7.2** <u>High School Athletes</u> must have competed in at least **five (5)** CAA approved meets in order to be eligible to participate in the State Championships. <u>Junior High Athletes</u> must have competed in at least **four (4)** CAA approved meets in order to be eligible to participate in the State Championships.
  - **25.7.2.1** Athlete must meet time and/or mark standard of the registered event as determined by CAA.
  - **25.7.2.2** Maximum entry of 4 athletes per school, per event.
- **25.7.3** Coaches may be asked to provide documentation that athletes are eligible for the State meet.
  - **25.7.3.1** Evidence may include copy of entry forms, printed meet results, etc.
- **25.7.4** State Entry Fee will be determined by the CAA Executive Board on an annual basis.
