5.4.1 In State Transfers— a student shall be ineligible for all contests at all levels if transferred to a different school after August 1st of the current school year, OR until after the first half of the minimum regular season contests, stated in those sports in which the student participated during the twelve (12) months immediately preceding the transfer.

New Business:

2026-2028 High School and Junior High Classification Placement

26–28 Classification Placement

The Executive Board reviewed and discussed the proposed 2026–2028 Division Alignment and Classification Placement model for high school and junior high sports. The model establishes enrollment-based divisions by sport, including one-division, two-division, three-division, and four-division structures depending on participation numbers and competitive balance.

After discussion regarding competitive equity, scheduling consistency, and long-term association growth, the Board approved the 2026–2028 Classification Placement framework as presented.

This classification model will be implemented beginning with the 2026–2027 school year and remain in effect through the conclusion of the 2027–2028 school year, unless amended by Board action.

Document will be emailed out to members prior to January 30th for review with region and division placement. Appeal process information will be provided at this time.

Constitution Meeting Planning Update

- The Executive Board reviewed and confirmed planning details for the upcoming Constitution Meetings scheduled for **March 25** (High School: **9:00 AM–1:00 PM**; Junior High: **4:00 PM–7:00 PM**). Discussion included the proposed meeting agenda, review focus areas within the Constitution, the draft Legislative Council proposal including updates to **Article 3**, meeting structure, and the Board election process.

Annual Athletic Director Conference Update

- The Executive Board reviewed details for the **Annual Athletic Director Conference** to be held **July 24–25, 2026**, at **Talking Stick Resort, Scottsdale, Arizona**. Discussion included confirmation of the site and dates, planned presenters, key educational topics, and the inclusion of an exhibit hall featuring association partners and vendors.
